THINGS YOU OUGHT TO BE AWARE OF

Internet Scam

The Better Business Bureau reports in their January/February 2003 newsletter that there is a scam being run by a Web-based business calling itself The Consumer Protection Agency

(www.consumerprotectionagency.com). This company, which has no street address, post office box, or telephone number, claims that they will file complaints with the Better Business Bureau for you for a fee of \$4.95. The BBB emphasizes that there is no need for anyone to ever use a third party to file a complaint against a business or other organization with them. Complaints can be submitted online at www.bbb.org or by letter or telephone to your local bureau.

The BBB tracked down this organization and found that the Website is registered to Online Application Corporation of Forest Hills, New York, which is a subsidiary of Taxes by CPA, a firm that has been the subject of 43 complaints to the BBB over the last three years.

Credit Card Swiping

If you assume your credit card is in safe hands when you use is to pay your bill at a retail shop or restaurant, you may be in for a shock. Your card could be in the hands of a "skim artist."

Credit card skimming has been around for a decade, but has risen in the past two years. Here's how it works. Skim artists recruit "go-fers" who then find temporary work in various establishments. The recruits are given small, illegal electronic devices known as skimmers that capture all of the credit card or debit card details in the little time it takes to swipe the card through the legitimate credit card machine.

When unsuspecting customers go to pay their bill, their card is first swiped through the legitimate credit card machine and then is also secretly swiped through the smaller machine. The go-fers then pass the gadget to the skim artist, who pays them cash for their part in the crime.

Once the skim artist has the details, he downloads the information onto a computer and makes a fake card. The "cloned" card is embossed with the details of the victim's credit card and passed to others, who may sell the card or use it for their own benefit.

We all need to check our monthly credit card statements carefully and report any suspicious or unverifiable charges to the credit card company promptly.

Fraudulent Escrow Accounts

No, these are not like the escrow accounts that mortgage companies use to accumulate money to pay your insurance premiums or taxes. If you buy items at auction through eBay or other online auction services, you may have found that for expensive items (say \$1000 or more) many auctioneers and bidders use an "escrow" system. Escrow means that the winning bidder sends his cash to a neutral third party to be held, usually until the goods are shipped and the bidder is satisfied with their condition. The benefit is that the escrow company is supposed to be a neutral party to the transaction, a middleman, that protects both the auctioneer and the bidder in case something goes wrong. Of course, there is a charge for this service.

Well, some folks are taking advantage of this system to bilk bidders out of thousands of dollars. It's scarily simple: the scammers, working in cahoots with the auctioneer, set up a phony escrow company, complete with its own Website. When you place the money "in escrow," you're just sending it to the scammers, who then use stalling tactics to explain why the auction hasn't cleared escrow. Eventually they fold their tents and flee, and you're left thousands of dollars poorer with no recourse. To be safe, use an escrow service recommended by the online auction site. For example, eBay recommends Escrow.com.

Scammers Posing as "Do Not Call" lists

Scam artists capitalizing on the popularity of existing state "do not call" lists and the proposed Federal Trade Commission (FTC) "do not call" registry have devised yet another method to trick consumers into giving up personal information such as their Social Security number, bank account number, credit card number or telephone calling card number.

Here's how the scam works. Someone calls you claiming to represent a "do not call" registry or the FTC. The phony registry "official" asks for your

personal information, supposedly to verify that you are on the "do not call" list.

The caller than could use your personal information to run up debts in your name or otherwise steal your identity.

Once a consumer signs up with a state's actual "do not call" registry, there is no need to confirm personal information. The FTC advises everyone to never share personal information with anyone not known to that person and, in fact, don't even stay on the line.

Editor's Note: One method I have found effective in dealing with tricksters of this kind is to tell them you can't give them the information right then because you are in the middle of entertaining company or are late for a doctor's appointment. Ask for the exact company name, the name of the caller, and a number where they can be reached with a call-back. After you hang up, call the BBB or contact the appropriate state agency to verify that this company is legitimate. Chances are that the caller will give you a runaround. That is a very good clue that this caller is not legitimate and your best reason to hang up.
