The program for the July 14th meeting will feature former U.S. Secret Service Agent Terry Oden who will draw on his 24 years of experience for his remarks.

During his time in the Secret Service significant assignments included Protective Detail for Mrs. John F. Kennedy (Mrs. Jacqueline Kennedy Onasis) 1964 - 66 and the LBJ White House Detail from 1966 to 1970. Other assignments included 4 years as Special Agent in Charge of International Operations based in Paris, France. He was Attaché at the American embassies in Germany, UK, Belgium, Denmark, Austria and France.

Some of his other duties were Security Coordinator at the 1984 Democrat National Convention as well as the Birmingham City Stages 1991 - 95. He was one of the first 25 Sky Marshalls in 1970.

At the present time Mr. Oden is owner of Security Resources & Solutions, LLC, an independent nonaffiliated security consulting firm specializing in risk assessment security surveys and audits, developing security plans and procedures, designing closed circuit television and management systems.

Terry is a protection professional certified by the American Society for Industrial Security and will present a very timely and interesting program, one you will not want to miss.

ITEMS OF INTEREST

Within the past couple of months, we have received at our house two solicitations for information (and money) that look very official, but are actually from private concerns. Things like this always pique my interest, so I set about finding out more about these two organizations.

The first of the two organizations is the *Traditional Values Coalition*, which used a return address of Hagerstown, Maryland. The letter, addressed to Myrna, bore the salutation "Dear Christian Friend." The letter accompanied a 6-page survey and a 1-page solicitation for money to help cover the cost or preparing and processing the survey.

The whole package looked very professional. They had gone to the trouble of identifying our correct voting district so that they could remind us who our U.S. Representative is. However, I took the time to inquire through the Wise Giving Alliance Web site maintained by the Council of Better Business Bureaus. Here is what they have on record for this organization.

First, the addresses on file for the Coalition are in Anaheim, California, and Washington, DC, not Hagerstown, Maryland. Second, the CBBB reports, "Despite written BBB Wise Giving Alliance requests in the past year, this organization has not provided current information about its finances, programs and governance.

"Traditional Values Coalition is tax exempt under section 501(c)(4) of the Internal Revenue Code. Contributions and membership dues *are not deductible as charitable donations for federal income tax purposes*.

The second solicitation came from an organization calling itself the *National Committee to Preserve Social Security and Medicare.* They are headquartered in Washington, DC. Again, the CBBB Wise Giving Alliance reports that their stated purpose is "to protect, preserve, promote and ensure the financial security, health and well being of current and future generations of maturing Americans." They were incorporated in 1982 and also do business under their primary name as a PAC and as a sister organization called Setting Priorities for Retirement Years (SPRY) Foundation.

Because the national committee is a PAC and not a charity, contributions *are not deductible from federal income taxes*. The BBB's comments on this organization are as follows: "The committee advocates and lobbies Congress on issues of concern for older Americans and others interested in Federal entitlement programs. In addition, through its magazine *Secure Retirement* and other mailings, the Committee organizes and encourages its membership to communicate their views to their Senators and Representatives."

There is more, but it runs along the same vein. BBB does note, however, that approximately 48% (\$9,330,000) of the Committee's program services are carried out in conjunction with fund raising appeals. Fund raising and membership development costs were 23% of related contributions and membership dues last year.

On the surface, this organization appears to your editor to parallel much of the AARP agenda, but spends considerably more on fund raising activities.

I present this information solely to keep you informed of solicitations that appear to offer potential for scams or pseudo-scams. If you are interested in knowing more about either of these organizations, contact the Better Business Bureau.

COMPASSION Compassion, in action, would transform our nation and the world

As early as 520 BCE the Old Testament prophet Zechariah criticized people who observe religious formalities and prescribed rituals but are not truly religious because they fail to exercise compassion. In a telling verse (7:9), Zechariah writes, "Execute true judgement, and show mercy and compassion, every man to his brother."

Have we changed much in the millennia since Zechariah? One could argue that the majority of people today still formally observe their faith tradition, but do not live in its true spirit of love and compassion. Witness the recent terrorist attacks on America and the ongoing crises of the Middle East. The English word *compassion* is derived from Latin and means "with suffering." Yet few today truly

feel the suffering of others, help share their burdens, and love each other as brothers.

Compassion leads us out of our shell of selfcomplacency and into the harsh reality of everyday life to stand beside another person who hurts. It makes us vulnerable by forcing us out of our comfortable worship centers, where most religion seems confined, and into the real world where we can offer a cup of water to those who thirst, bind up the wounds of the injured, bring love and kindness in a hostile environment, and reflect the grace of God to everyone we encounter.

Compassion, as the Bible consistently teaches, is at the heart of true religion. Can we say with appropriate pride that we are such a person?
