IN THE SPOTLIGHT

JAMES E. EWING

Once again the Spotlight shines on one of our members who served in the armed forces to protect our freedoms, James E. Ewing. He wrote a booklet titled "Service in the U.S.M.C.—World War II" that contains pictures and notes about his experiences. You should ask James to tell you the story about how he ended up in the Marines, rather than the Army, Navy or Air Force. After training at Parris Island, South Carolina, Camp Lejeune, North Carolina and Camp Pendleton, California, he boarded a ship that took him to Guam for final training before he was sent to Iwo Jima. James was involved in battles across the island that resulted in victory on the northern shore at Kitano Point on his 19th birthday, March 16, 1945. His notes describe several encounters he and his fellow Marines had during their days and nights on the island; some were amusing, others tragic. The Iwo Jima campaign was costly in casualties, but provided an air base much closer to Japan. After the end of the war, James was sent to China to assist in the repatriation of Japanese military personnel who were stranded there.

The year 1946 was a good year; James was discharged from the Marines, returned to Alabama, met his future wife Billie Dean, enrolled at Howard College (now Samford University) and UAB, and was hired by Alabama Power Company (APC). His first assignment at APC was in the customer billing office under the direction of W. G. Shields. Other APC roles were in stores accounting supervised by David Hudson, and rates and marketing research managed by Chandler Murton. He then transferred to the power management group at Southern Services led by Robert Usry. James held a supervisory role in computer operations until his retirement after 38 years in the Southern Electric System.

James and Billie were married in 1948 and will be celebrating 57 years of marriage this year. They have two sons, but no grandchildren. For many years their homes have been in the Tarrant and Roebuck areas until a recent move to a garden home in the new city of Clay. After retirement, James and Billie traveled extensively, including two trips to Hawaii and a cruise to Alaska. Other travel took them to Canada and frequent trips to Florida beaches. Long trips are not on their agenda now, but they enjoy sharing other activities together.
