He left SCS in 1994 on a disability. In 1997 he became pastor of the First Baptist Church of Harpersville a position he held until his death. He is survived by his wife of 31 years, Patti Parish, 2 sons, his father and mother, both SCS retirees and 2 brothers. A funeral service was held for Dr. Parrish on Wednesday, January 3, 2007 with burial in Elmwood Cemetery, Birmingham.

# THE SPOTLIGHT SHINES ON BOB SMITH

Bob Smith is an Alabama native who graduated with a bachelor of science degree from the University of Alabama in 1965. He was enrolled in advanced ROTC, served 13 months in South Korea with the U. S. Army and continued his service for 28 years in the U. S. Army reserve, retiring as a lieutenant colonel.

Bob began his Southern Company Services (SCS) career in 1967 as a piping design engineer in the mechanical design discipline. He continued his education by receiving an MBA degree from Samford University. He was promoted to the position of assistant to vice president K. W. Boyles and later as an assistant to executive vice president Bill Lalor. His major assignment was to develop a project manage-ment system for design work on all operating fossil, hydro and nuclear plants. A company reorganization placed Bob in the production services department as a project engineer. One of the major

company initiatives was the pooled inventory management (PIM) program. PIM, which consisted of 24 electric utility companies that owned 52 nuclear plants, pooled resources to purchase expensive spare equipment that was interchangeable with multiple plants. This equipment is stored in a warehouse in Memphis, Tennessee. Bob had technical and program management responsibilities in PIM for over 18 years before retiring in August 2004. Bob cited a number of SCS individuals who had a positive influence on him, including Bill Gaskell, K. W. Boyles and Bill Lalor.

The PIM job required extensive travel with the accumulation of many frequent flyer miles. Travel, not because of the frequent flyer miles, became an important part of the activities of Bob and his wife Alice. They have vacationed in Europe 12 times and visited all 50 states. Bob will be traveling for three weeks in March 2007 to Africa with destinations in South Africa, Kenya and Egypt.

Tennis was a serious hobby for Bob for many years. He started the SCS tennis ladder and tournaments to improve his skills and to encourage more SCS personnel to get involved in the sport. He had major successes in the sport, finishing third in the Alabama State Closed Singles Tennis Tourna-ment in his age group and achieving a state ranking of fourth as a singles player.

Gardening (everything but vegetables) has now replaced tennis as a major hobby. Bob completed the master gardener course in 2005, and Bob and Alice's home garden has been featured in the Alabama Gardener magazine. Through his friendship with Eddie Aldridge, Bob was appointed to the Aldridge Gardens Board of Directors in 2005. Major additions are being planned for the gardens, including a children's garden, and Bob is one of the leaders in this expansion.

Bob and Alice have two children and six grand-children, who are now their number one hobby. Alice is a retired school teacher. SCS Retirees is fortunate that Bob has accepted a position on our Board of Directors in 2007.
