THE SPOTLIGHT SHINES on MONROE C. SMITH

Monroe C. Smith, the third of six children, was reared in East Lake and attended Robinson Grammar School and Woodlawn High School. All of his brothers and sisters were successful in a variety of professional areas. Since his family did not have an automobile, Monroe used the street car or his bicycle for transportation. While in high school, he delivered telegrams for Western Union on his bicycle, which he still owns. He also played violin and sang in the boys' choir at the Church of the Advent.

After one year in college, Monroe joined the Navy in 1942 to become a Navy pilot. His Navy service took him around the country. From the University of South Carolina he was transferred to Austin Peay University in Clarksville, Tennessee, which at that time was a college for women only. The college women and the Navy men shared a dormitory on campus, and the men continued their flight training. Monroe enjoyed flying a high wing plane, particularly doing spins and loops. Physical training and bookwork at the University of Georgia was followed by a transfer to Dallas to continue flight training. Monroe flew a two wing plane that was a great aerobatic plane. During these years, his father died and Monroe suffered a hernia problem that required extensive hospital and rehabilitation time.

When the Navy decided it had too many pilots, Monroe survived an interesting Navy selection process—put names on pieces of paper, throw them down a set of stairs and retain the pilots whose piece of paper landed on a "certain" step. His next major assignment included taking off and landing on a small aircraft carrier and testing torpedoes during night flight operations in the Bahama Islands area. He then flew several types of aircraft in an experimental squadron and ended his Navy career on a large aircraft carrier, the Franklin D. Roosevelt.

When he was discharged from the Navy, Monroe returned to Alabama and enrolled at Auburn Uni-

versity in the College of Architecture. After graduating with a bachelor degree, he was employed in the architectural department at Alabama Power Company under Don Simmons. After ten years at Alabama Power designing small office and crew headquarters buildings, he transferred to Paul Fischer's group at Southern Services. Primary architectural assignments included Plant Vogtle and Plant Farley under Tom Dowdle.

After a long battle with Parkinson's disease, Betty, his wife of 46 years, passed away in 2005. Their daughter and son-in-law have produced two "super" grandsons for Monroe to spoil. Monroe is 84 years old, plays golf twice a week and works as a starter four days a week at Vestavia Country Club.
