## In Memoriam

**Kenneth M. Rieck**, 83, of Fultondale, Alabama died on Sunday, September 20, 2009. He retired from the SCS Mechanical Design Department as a senior engineer on September 1, 1986, with 11 years of service. He was preceded in death by his wife, Darlene. He is survived by a brother, a sister and a nephew.

A Memorial service was held for Mr. Rieck at the First Baptist Church of Fultondale on Tuesday evening, September 22.

**James H. Miller, Jr.,** 86, of Atlanta, Georgia died on Tuesday, October 6, 2009. He was a retired executive of the Southern Company having served as Executive VP of Alabama Power Co. until 1975 and as President of Georgia Power Co. until his retirement in 1987. He was a WWII and Korean War Navy veteran, retiring from the Naval Reserve in 1982 with the rank of Captain. He is survived by his wife of 63 years,Juliet, two daughters, two sons, a brother, nine grandchildren and two great-grandchildren.

A funeral mass was held for Mr. Miller in Atlanta at the Cathedral of Christ the King on

Friday afternoon, October 9. A private internment followed.

## **Car Thieves Have Their Ways**

Seems that car thieves have found a clever way to steal your car or truck without any effort at all. The car thieves peer through the windshield of your car or truck, write down the VIN from the label on the dash, go to the local car dealership and request a duplicate key based on the VIN. [*ed. note: this does not work with ALL vehicles, just most of them.*]

Upon calling a friend at Chrysler and pretending I had lost my keys, they told me to just bring in the VIN and they would cut me one on the spot, and I could order a keyless device if I wanted one.

The car dealer's parts department will make a duplicate key from the VIN and collect payment from the thief, who will then return to your car. He doesn't have to break in, do any damage to the vehicle, or draw attention to himself. All he has to do is walk up to your car, insert the key and off goes your car for a joy ride or to a chop shop.

You don't believe it? It IS just that easy.

To prevent this happening to you, simply cover the VIN metal label plate located on the dashboard. By law, you cannot remove the VIN plate, but you can cover it so it can't be read through the windshield by a car thief.

[ed. note: Ordinances may vary from city to city or county to county. And the maker of your vehicle may have taken steps to prevent this problem. You might want to inquire.]
