How does someone get to a real live person at Hewitt without knowing passwords and IDs? Here is the answer: You still must be prepared to provide the personal information necessary to identify yourself or the person you are calling for.

There are two ways.

Hewitt Direct. Monday through Friday between the hours of 8 a.m. and 8 p.m. you can call Hewitt at 1-888-435-7563. When their automated system answers, and after it asks for your ID, press \*0# (star, zero, pound). Someone will answer.

**HR Direct.** Monday through Friday between the hours of 8 a.m. and 6 p.m. call 1-888-678-6787and select Option 3. You will get a contact person who will transfer you to the right Hewitt benefit person.

# MEET OUR FOUNDING MEMBERS The Spotlight Shines on Jerry Vandegrift

Jerry Vandegrift had a long and productive professional life at SCS. When he retired he was Director of System Planning. But jerry has never really retired, not fully at least. He was one of the founding members of our retirees group, and was the group's first President. As is our normal leadership progression, Jerry spent the following year in the leadership mix as an ex officio member of the Board. But his service to his fellow retirees did not stop there. He also spent two years as an elected director, a year handling Member Care, and three times on the nominating committee.

When I said jerry has never fully retired, I was not speaking lightly. After retiring from SCS, Jerry handled the electrical engineering required to place a hydroelectric generating plant into service in the Democratic Republic of Congo. This generating plant became the reliable source of power for a mission hospital.

The task of bringing this plant from drawingboard to completion required four extended trips over a span of years. Jerry, though now legally blind, continues to serve as a consultant to the project.

Jerry and his wife Dean have a long history of partnership in volunteer work on behalf of the Congo, both at home and abroad.

Jerry has also been active in his church since retiring, having served as an Elder, a Trustee of the presbytery and a Moderator of the Presbytery Coordinating Council.

Jerry and Dean joined their lives in marriage March 13, 1954, and just celebrated their 59<sup>th</sup> anniversary. They live in Mountain Brook and have two living children and one grandchild nearby.

But Jerry and Dean have not been all work and no play in retirement. They have vacationed in some interesting, and sometimes exotic, places, including Germany, Austria, the Czech Republic, Yugoslavia, England, Scotland, Wales, Alaska, Israel, Egypt, Canada, Yucatan, Greece, D.R. Congo and Kenya. Oh, and they also found time to visit New England and Florida as well.

Gray Murray has some thoughts about three different topics he wanted to share with you.

#### **SERVICE:**

Purpose #5 of our SCS/SNC Retiree Organization is stated in our Articles of Incorporation as follows:

# A LITTLE OF THIS, A PINCH OF THAT

#### AS MANAGING EDITOR OF...

The Colubus (Ga.) Ledger-Enquirer in the midsixties, I remember my "office."

I called it my office, but it was really just a fenced-in area in the newsroom, with a swinging wood gate.

They were having a governor's race in Georgia in 1964, and this sandy-haired young man was running in a race he couldn't win. He came by the newspaper to shake some hands. It was a hot day, and he was taking his time. The newspaper was airconditioned.

He went to see the publisher, who handed him off to Carlton Johnson, the editor of the Ledger. Carlton talked to him for a little while, then handed him off to me.

I looked up and there was Carlton, outside my little gate, introducing him to me. I could see Carlton wanted me to talk with him so he could go back and write some more editorials.

So he pushed open the swinging door to my "office," and sat down in the visitor's chair.

He told me about his Navy experiences, and I told him some sea stories from my Navy time during the Korean War. He talked about life in a small town, and I told him about growing up in the small town of Thomaston, Ala.

We talked for about an hour. Like I said, it was a hot day, and the air conditioning was better than walking the hot streets. I really enjoyed talking with him, even though we were both aware that he was losing this one.

He finally left, and we shook hands. I really liked him. Four years later, he made another run for

governor, and this time he won. And in 1976, he ran for the White House, and won it.

I was rooting for him the whole way. I was glad to see a Southerner with class win the presidency.

While he was running for governor and president, I changed newspapers. I went from Columbus to The Birmingham News.

While I was city editor of The News, I got an invitation to a briefing at the White House. President Carter invited newspaper people from all over the U.S., about 30 of us, to the briefing.

We listened to generals and government big shots tell us about the state of the government. Frankly, they talked government jargon, and I don't remember a single thing they said. What they didn't tell us was that hostages in Iran would cost Jimmy Carter the presidency in 1980.

The last meeting was in the White House, and we were all sitting around this big table, with Jimmy Carter smiling, showing those big teeth, at the other end.

At the end, we all filed out, and each one of us shook his hand. When it came my turn, I reminded him of our talk in the newsroom about 10 years before. And he remembered. He remembered how hot it was, and how glad he was to sit down in an air-conditioned place. He even remembered what we talked about. I guess I was flattered that he would remember a chance encounter a long time before.

Later, of course, the Ayatollah took U.S. hostages in Tehran, and Jimmy Carter took the fall for it.

After he left office, Jimmy Carter took on the mantle of leadership as an ex-president, brokering an agreement here, stepping in as a mediator there, helping to build a Habitat for Humanity house.

#### **ORB MONSTERS**

If you have ever been outside at dusk in late summer or early autumn, you have probably seen some big brown spiders that spin some pretty amazingly large webs. Officially known as members of the family Araneidae, they are commonly called orb weavers.

To me, they are more like man-eating monsters. When I was a kid, I saw a horror movie where a grown man was actually trapped in a giant spider web and the horrendous, red-eyed arachnid was working its way toward its prey. I could not stand seeing the poor fellow being eaten, so I closed my eyes and turned away from the TV. I do not know how the scene ended, but it could not have been any more terrifying than when I unwittingly stumbled into an orb-weaver's lair.

It actually happened on two occasions. The first encounter was in an old cemetery in Cherokee County, and I very nearly became its newest occupant. I like to stroll through old graveyards and visit the final resting places of soldiers who fought in the Revoluionary War, War of 1812 and Civil War. This particular day yielded no results, and on the way back to the car I glanced down at the ground for some reason. When I looked back up I was literally face to face with the horrid beast!

The web was all over me, and the half dollar-sized spider was dangling from the bill of my cap. All eight legs were thrashing about as it desperately tried to climb up to the top of my head. I let out a yell that was probably heard throughout all of north Alabama and west Georgia. Thrashing every bit as much as the spider, I threw my clipboard about twenty yards and then set the world record for cap flings. If anyone had driven down the road n front of the cemetery, they would no doubt have thought that I was having some sort of spastic fit.

Shoulders heaving from heavy breathing, it took several minutes for me to gather myself and muster up enough courage to go pick up my things. Of course I kicked at my cap and then violently shook it, just to be sure the killer was gone. These creatures are non-poisonous, but a blood pressure spike can nevertheless lead to a stroke.

Ain't no way I'm walking into another one. The third time's the harm!
